Reportable business positions in any business entities having an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this Conflict of Interest code, services subject to the approval or review of the Transportation/GIS Manager, whether such approval or review is performed on behalf of the City or the Community Redevelopment Agency.
29. Reportable income from persons and business entities having an interest in real property in the jurisdiction or that provide, plan to provide or have provided within two years prior to the time a statement is required under this Conflict of Interest Code, supplies or services to the City or Community Redevelopment Agency within the jurisdiction subject to the inspection or approval of the Parks Maintenance Supervisor.

30. Reportable investments in any business entities having an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this Conflict of Interest Code, supplies or services to the City within the jurisdiction subject to the inspection or approval of the Parks Maintenance Supervisor.
31. Reportable income from persons and business entities having an interest in real property in the jurisdiction or that provide, plan to provide or have provided within two years prior to the time a statement is required under this Conflict of Interest Code, supplies or services to the City or Community Redevelopment Agency within the jurisdiction subject to the inspection or approval of the Sanitary Sewer Collection System Supervisor.
36. ## **CONSULTANTS DISCLOSURE CATEGORIES**

1. For consultants who serve in a staff capacity with the City, the consultant shall disclose based on the disclosure categories assigned elsewhere in this code for that staff position.
2. For consultants who do not serve in a staff capacity for the City, the following disclosure categories shall be used:

Persons required to disclose in this category shall disclose pursuant to categories A, B, C and D below unless the City Manager determines in writing that a particular consultant is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements in categories A, B, C and D. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The City Manager's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.

- A. Reportable interests in real property in the jurisdiction. (FPPC Form 700, Schedule B.)
- B. Reportable income and business positions. (FPPC Form 700, Schedules C and D).
- C. Reportable investments. (FPPC Form 700, Schedules A-1 and A-2.)
- D. Reportable gifts and travel gifts. (FPPC Form 700, Schedules E and F).
