COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF PALMDALE DISCLOSURE CATEGORIES

1. Reportable interests in real property in the jurisdiction.
2. Reportable income from persons and business entities having an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the review or approval of the Community Redevelopment Agency of the City of Palmdale.
3. Reportable investments in any business entities having an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the approval or review of the Community Redevelopment Agency of the City of Palmdale.
4. Reportable business positions in any business entities having an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the approval or review of the Community Redevelopment Agency of the City of Palmdale.
5. Reportable income from persons and business entities involved in the construction or renovation of housing, that have an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the review or approval of the Community Redevelopment Agency of the City of Palmdale.
6. Reportable investments in any business entities involved in the construction or renovation of housing, that have an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the approval or review of the Community Redevelopment Agency of the City of Palmdale.
7. Reportable business positions in any business entities involved in the construction or renovation of housing, that have an interest in real property in the jurisdiction or that provide, plan to provide, or have provided within two years prior to the time a statement is required under this conflict of interest code, supplies or services subject to the approval or review of the Community Redevelopment Agency of the City of Palmdale.
8. Persons holding designated positions which are assigned a disclosure category of "8" are not required to report under this Conflict of Interest Code because they

hold positions within the City of Palmdale which are required to report pursuant to California Government Code Section 87200. Persons in this category "8" are, however, subject to the disqualification provisions of this Code when acting in their official capacity for the Community Redevelopment Agency of the City of Palmdale.

9. Persons holding designated positions which are assigned a disclosure category of "9" are not required to report under this Conflict of Interest Code because they also hold positions that are required to report pursuant to the Conflict of Interest Code of the City of Palmdale. Persons in this category "9" are, however, subject to the disqualification provisions of this Code when acting in their official capacity for the Community Redevelopment Agency of the City of Palmdale.
10. For consultants who serve in a staff capacity with the Community Redevelopment Agency of the City of Palmdale, the consultant shall disclose based on the disclosure categories assigned elsewhere in this code for that staff position.
11. For consultants who do not serve in a staff capacity for the Community Redevelopment Agency of the City of Palmdale, the following disclosure categories shall be used:

Persons required to disclose in this category shall disclose pursuant to categories A, B, C and D below unless the Executive Director determines in writing that a particular consultant is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements in categories A, B, C and D. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Executive Director's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.

- A. Reportable interests in real property in the jurisdiction. (FPPC Form 700, Schedule B.)
- B. Reportable income and business positions. (FPPC Form 700, Schedules C and D).
- C. Reportable investments. (FPPC Form 700, Schedules A-1 and A-2.)
- D. Reportable gifts and travel gifts. (FPPC Form 700, Schedules E and F).
